HCCF Investments Rebound -Assets Top \$115,000,000

After the devastating decline in the market during 2008, invested assets held at the Foundation have made a dramatic recovery. After a slow start, gains posted during 2009 reached 23.2 % followed by 14.2 % in

Total assets held by the Foundation and the Supporting Organization at the close of 2010 were \$115,352,231. This amount again places the Harrison County Community Foundation in the top 100 in total assets of over 900 community foundations across the country and the third largest in the state.

'Our investment strategy includes diversifying our holdings in a manner to reduce our market value losses during the bad times yet take advantage of opportunities during periods of growth," explains Bill Thomas, the Finance Committee Chair. 'I believe we weathered the economic storm of 2008 very well."

The total assets held in the Unrestricted Fund closed 2010 at \$52,259,579. Adhering to the 5 % Spending Policy, \$2,612,979 is available in 2011 to support grants, scholarships, and operations. Another \$510,868 is available based on the spending allowance on new funds contributed by

Horseshoe Southern Indiana during 2010.

"All non-profits have operating costs," adds Thomas. "The HCCF operating budget, at .5 % of our asset market value, continues to be one of the lowest in the nation."

The Harrison County Community Fund, the endowment to benefit Harrison County government, equally benefitted from the rebounding market. Assets in the fund on December 31, 2010 were \$46,847,461. By the spending allowance, this fund is generating \$150,000 a month that can be used for projects agreed upon by the Commissioners and County

The Foundation works with an independent public accounting firm to perform an annual audit of financial statements and records. The auditors also conduct a review of internal controls and meet each year with the HCCF Audit Committee. Match Program a Winner 2:1 Opportunity in 2011 ongoing financial support, but they're not

The Harrison County Community Foundation announced a dollar-for-dollar match program in January 2000. Since that beginning, the Foundation has provided \$4,250,000 in matching dollars into HCCFheld endowments chosen by nonprofit agencies and private individuals.

The first double-match offer occurred in April 2006 to celebrate National Library Week and stimulate the creation of school library endowments. Fifteen school libraries rallied to raise over \$90,000 to support their funds.

A second double-match occurred in 2009 in celebration of National Philanthropy Week November 12 – 18. A third 2:1 match was offered the entire month of November in 2010. For 2011, a restricted double-match is available for gifts into three specific endowment funds.

'We have two Foundation-led programs; Dolly Parton's Imagination Library and the Youth as Philanthropists," said Endowment Committee Chair Don Dones. "Both have endowments that provide


yet at the level we want them. The doublematch is our way of encouraging funding partners to sustain and grow these programs."

In addition to the Early Reader's Fund supporting the Imagination Library and the Youth Philanthropy Fund supporting youth-led grantmaking, the IU Southeast Scholarship Fund has also been selected to benefit from the special double match. The IUS Fund has resources to fund two \$5,000 renewable scholarships each year.

"We want to fund four scholarships to IU Southeast," Dones added, "one to graduating seniors at each of our four high schools." Currently, students from all four high schools compete against each other for the two \$20,000 awards.

The Community Foundation launched Dolly Parton's Imagination Library program in Harrison County in October 2007. The program provides a free home library for all registered pre-school resident children until their 5th birthday.

Founded in 1996, Dolly Parton's Imagination Library (DPIL) is a 501(c)3 nonprofit providing thousands of books each month to registered children in participating communities all over the United States, Canada, and the United Kingdom. DPIL works with publishers and arranges the monthly mailing of the age-appropriate

Dictionary Project Delights Students

Each year, the Harrison County Community Foundation purchases the $Webster's \ Dictionary \ for \ Students \ for$ every third grader in Harrison County. Third graders are targeted as that is typically when students are transitioning from learning to read to reading to learn.

"I am always surprised at how excited the students are when we show up to pass out the dictionaries," said Steve Gilliland.
"It feels a little like Christmastime."

Most teachers have already been teaching their students about using a dictionary. And many have lesson plans to guide students on how a dictionary is used to help them pronounce and understand the meaning of words.

The dictionary provided in Harrison County schools is the Special Encyclopedic Edition containing other resources such as a list of the presidents, weights and measures conversion, world maps, states and capitals, and the Declaration of Independence. Every student, their teachers, and the school library receive the same edition so everyone has the same reference avail-

The idea for The Dictionary Project began in 1992 when Annie Plummer of Savannah,

Georgia, gave 50 dictionaries to children who attended a school close to her home. Each year she continued to give this gift, raising money to help give more and more books so that in her lifetime she raised enough money to buy 17,000 dictionaries for children in Savannah.

Today, The Dictionary Project is a 501(c)3 nonprofit serving all 50 states and over 15 other countries. They coordinate orders, negotiate costs, and arrange shipping. Since implementation in 1995, over 14,000,000 dictionaries have been distributed through the program. Foundation & County **Preserving History**

The Foundation and county government continue to find ways to work together; this time to preserve a piece of our history. The cabin built in the 1800s and moved to the Battle of Corydon Memorial Park over sixty years ago had fallen into disrepair. Reluctantly, the park's advisory board agreed a replacement should be found.

Just about this time, call it fate or luck, Sharron Gillion contacted the Parks Department to see if they would like to have a log cabin that had to be removed from property she owned just a few miles southeast of Corydon. The cabin had been in her family for many years and was originally built in Harrison County in the 1830s.

We may never know who was more delighted – the donor or the recipient. Either way, the cabin has a new home; helping to tell the story of life in Harrison County. Just in time, too. The 150th anniversary of the Battle of Corydon will be July 9, 2013.

Bob Powell, an architect from Cincinnati specializing in preservation, was selected as the project manager. James L. Shireman, Inc. was chosen to disassemble. move, and reassemble the cabin. Shireman's Leland Kitterman has been the on-site construction manager. Great care has been taken in every detail of the project to ensure the structure survives another 150 years.

In addition to funding from the Foundation and county government, the Historic Landmarks Foundation of Indiana provided \$2,000 for a feasibility study.

Elizabeth Lions Club Announces New Fund

The Lions Club of Elizabeth, Indiana Fund was established in December 2010 to lend support to the Elizabeth Lions Club for causes that are charitable, religious, educational, scientific, literary and/or preventing cruelty to children or animals.


The Elizabeth Lions Club was established in 2003 and currently has 40 members. The club works to address needs within the community including assistance with eye glasses, construction of handicap-accessible wheelchair ramps, sponsorship of SHAC teams, and fundraising for other charities such as the Foundation Fighting

Additionally, the club hosts special fundraising events to, among other things, help individuals or families fighting illness or recovering from the loss of a house-fire. The club also provides a \$500 scholarship each year to a graduating senior from South Central High School.

Revenue from the club's primary fundraiser, the annual Golf Scramble held at Chariot Run in Elizabeth, made it possible to open this fund. This was a big decision, but the members believe the fund will provide a permanent future source of funding for service within the Elizabeth community.

Sanders Financial Markets Lab Support Fund



Judge Carlton Sanders and his wife Sue continue to provide opportunities to students at Indiana University Southeast. This fund will provide support to enhance applied educational opportunities in financial and economic literacy for students from Harrison County, both traditional and nontraditional, and others at Indiana University Southeast.

The Sanders Financial Markets Lab officially opened at IU Southeast and classes were started in the fall semester of 2010. The lab, funded in part by a generous donation from the Sanders, allows IU Southeast School of Business students to experience real-world applications of stock market and financial techniques. Complete with stock tickers, flat-screen televisions, real-time stock quotes and access to the latest financial software, the

Sanders Financial Markets Lab is a stateof-the-art lab that will prepare students for the transition from classroom to Wall Street.

The original gift from the Sanders that created the lab gave IU Southeast a resource that no other institution in our region has. "In short, this gift will make certain that the Sanders Financial Markets Lab remains state-of-the-art for the foreseeable future," states Dean of IU Southeast School of Business, Jay White.

Judge Sanders is a former Harrison County superior court judge who serves Southern Indiana as a special judge and judge pro tem. Sue Sanders retired in 2000 from Aegon Insurance Group. Both earned bachelor's degrees in business from IUS.

Foundation Awards over \$584,000 to the Class of 2010

The Harrison County Community Foundation awarded 220 scholarships totaling \$584,100 to the Harrison County high schools Class of 2010.

The Building Our Future scholarship program was awarded for the fourth year and has now provided \$800,000 in awards. This was the first renewable scholarship program of the Foundation. Ten recipients receive \$5,000, renewable each year upon meeting criteria for four years, for a total of \$20,000.

Through the Founders Scholarship program, HCCF allocated the following amounts to each school based on the reported number of seniors enrolled in January 2010: Corydon Central \$115,438; Lanesville \$30,415; North Harrison, \$110,599; South Central \$43,548. These scholarship

awards were distributed among 121 graduating seniors throughout Harrison County. The Foundation required that at least 10 percent of each school's total amount be distributed to students entering a certified vocational training program. The minimum awarded to any recipient was \$1,000. Individual school's Scholarship Advisory Committees recommended recipients and amounts awarded for both of these **HCCF Scholarship Programs.**

Additionally, over \$84,000 in scholarships were provided to 89 graduating seniors from charitable scholarship funds created by members of the community. The HCCF holds over 70 scholarship funds and continues to match donations to all HCCF held endowments. New scholarships

awarded for the first time in 2010 were the Laconia Lions Club Scholarship at South Central High School and the Larry A. Gettelfinger Memorial Scholarship and the Harrison-Crawford BAR Association Scholarship awarded at North

Harrison High School. The Foundation also holds scholarship funds established by some of the local colleges including Ivy Tech Community College, Indiana University Southeast, Spalding University and Bellarmine University. Endowments Benefit Libraries



Did you know there are 16 libraries in Harrison County? Did you also know each one of them has an endowment fund that helps them purchase books, periodicals, and equipment?

To celebrate National Library Week in April 2006, the Harrison County Community Foundation offered the first double-match program to every school library that chose to participate. Apparently, schools, students and the community liked the idea. In just two weeks, the community had contributed \$91,397 leveraging \$182,794 of Foundation match. At the end of 2010, the combined value of these funds was \$351,842; \$24,080 has been provided to the libraries, and \$44,237 is available to spend.

The South Central Media Center now benefits from the Helen and Russell Petty Media Fund created in April 2009. Part of the funds purchased a Promethean Smart Board, to be shared by teachers and students; thus the media center was born.

The Harrison County Public Library also has HCCF endowments supporting their work; four of them! The George L. Hess Family Library Fund, the Harrison County Public Library Fund, the Frederick Porter Griffin Fund for Genealogy and History joined by the Marilyn M. Rhodes Memorial Fund created in December 2010. Each fund has similar but separate directed purposes to support the library's services.

Internships Available at HCCF

A paid internship opportunity became available at the Harrison County Community Foundation beginning in the Fall 2010 semester and continuing through the Summer 2012. Interns will be indoctrinated into the many facets of community foundation operations from grant applications to donor services.

YMCA Endowments "Open Doors"



The YMCA of Harrison County has an endowment fund at the Foundation that helps support the Open Doors program. The Open Doors financial assistance program makes it possible for everyone to enjoy what the Y has to offer, regardless of their ability to pay membership or program fees. Those unable to pay the full fee may apply to receive sliding-scale rates. Open Doors assistance is granted based on personal need, enrollment limitation and the Y's financial resources.

Costs for participation, however, must be met with other resources. That's where the YMCA Fund steps in; helping to offset the costs of operating the facility and programming. In 2010, the YMCA's endowment fund provided \$13,900 to help ensure YMCA programs were available to everyone.

The YMCA Fund also helps defer costs of the Third Grade Swimming Lessons. Offered free to every third grader in Harrison and Crawford Counties, the YMCA has taught over 3,000 children how to swim and stay safe around water.

It affirms our commitment to financial security, transparency and accountability.

Policy On Availability of Financial Information

It is the policy of the Harrison County Community Foundation and Harrison County Community Foundation Supporting Organization to follow the rules and regulations of the IRS regarding public availability of our Forms 990 as well as any other required documents. Public Availability of IRS Forms 990 and Audited Financial Statements:

1. Public inspection copies of the audited financial statements and Forms 990 are available the same day to anyone who requests them in person at our office.

2. The Forms 990 for the last year as well as audited financial statements are also available at our website www.hccfindiana.org. Forms for the last two years are available from our office upon request.

The Foundation office also can provide a list of financial managers and bodies

responsible for investment and oversight upon request. The Foundation does not charge administrative fees on endowed funds held by the Foundation and serving Harrison County (Indiana) purposes. The current investment management fees assessed are 62 basis points. Administrative fees of one percent (1.0%) are charged on all Planned Gift instruments.

Frequently asked questions about Grants

Who can apply?

All not-for-profit agencies providing services to residents of Harrison County, Indiana are eligible to apply. We suggest everyone interested review the Grant Policy on our website

When are applications due?

Grants are typically awarded twice a year. Applications are accepted between December 1 – January 15; and again June 1 – July 15. Grant Making Policy and Procedures, Applications, and Deadlines are posted on the HCCF website. Grant requests of \$200,000 or more are called Signature Grants. These are accepted only from November 1 to December 15. Decisions for Signature Grants may be announced anytime during the following year.

What if the money is needed now?

We are aware that some state or federal grants requiring local matching funds are announced on short notice. To support this, the HCCF will consider special grant requests anytime. Request letters must arrive at the HCCF office prior to 4:00 pm on the Monday before the monthly Board of Directors meeting (typically, the first Monday of each month.) Contact Steve or Julie for guidelines.

Emergency grants are awarded to respond to true emergency needs of our community or those that prevent an agency or program from carrying out primary functions or services. Applicants should call the HCCF office to discuss their need and determine additional information the board may require.

How can I get more information?

HCCF staff will provide workshops to all eligible not-for-profits serving our community on the proper completion of our grant application. All applicants are strongly encouraged to attend these sessions, typically held in May and November. Feel free to call us anytime with questions.

Who makes the decisions to award the grants?

The Grants Committee Chair will assign sub-committees. Each sub-committee receives a similar number of applications for review. Individuals evaluate the applications and the sub-committee convenes as a group to determine a final ranking. Once the sub-committees have concluded their work, the Grants Committee meets as a whole to review, score and/or rank all applications. The final recommendations are presented to the entire Board of Directors as a motion for approval. The Board of Directors will make a final determination and formally approve the amount to be awarded. This decision is final and will be announced via formal letter.

Grant Writing Tips

- Include ALL documentation. Follow the checklist and instructions explicitly.
- Statistics specific to Harrison County residents are helpful to justify your proposal.
- Ask someone who is not familiar with the project to read and critique your application.
- \bullet Thoroughly read all Grant Policies and call the staff if you have questions.
- Lastly, deliver your draft application at least a week before the deadline to allow the HCCF staff to preview.

Members of the Board of Directors and staff of the Foundation are committed to observing the highest standards of ethical conduct in the performance of our responsibilities. Our board and staff pledge and sign a Code of Ethics and a Conflict of Interest Disclosure that guide all of our processes and decisions.

Foundation Grants Leverage Resources

The Harrison County Community Foundation has a tremendous track record of awarding grant dollars that will leverage other external resources for a variety of projects throughout the community. Since 1999, the Foundation has awarded \$1,073,612 that has successfully brought an additional \$13,300.796 to projects benefitting Harrison County.

One example is the Senior Citizens Center in Palmyra. The Foundation provided \$124,875 that secured a \$500,000 Community Focus Fund grant award. Seniors and others in the area now have a beautiful facility to gather in.

Lifespan Resources was awarded \$33,939 for a local match in support of their transportation program. In their FY 2010, Lifespan provided 1,437

\$13,300,796

trips for seniors to medical appointments or the grocery store. Funding provided by HCCF in recent years has secured four vans with a total value of \$177,719. The Ramsey Fire Department was another beneficiary. A \$5,880 grant leveraged \$52,920 from the Department of Homeland Security to purchase pagers and an assortment of necessary rescue tools. Blue River Services has been the most successful in calling on the foundation for match support to building projects. In the past ten years,

They have been active in various organizations and were instrumental in helping to establish the Old Capitol Saddle Club in 1959. They owned the first registered




Quarter Horse in Harrison County. Carl served as president of various equine organizations, both at the regional and state levels. "Peggy has been a staunch supporter and has always assisted where she was needed," states Carl.

The Byerlys have long been supporters of the 4-H as both are past members. Carl was a member of the FFA during his four years in high school, held various FFA offices, and served on agricultural judging teams.

Ralph D. Best Memorial Scholarship Fund

A memorial scholarship, created by the family of the late Ralph D. Best, will benefit graduating seniors in Harrison County who wish to pursue a vocational training program in building trades such as carpentry, masonry, roofing or plumbing.

Ralph retired after 40 years of teaching in the New Albany-Floyd County School System, with time

By using his knowledge of woodworking, Ralph was able to do something he enjoyed and also give back to the community.

David R. Blank Memorial Fund



The Blank family established a fund to honor their father who passed away February 2006. This memorial fund will provide support toward equipment purchases and repairs at the St. John's Lutheran Church in Lanesville where David was a lifelong member. He served as its President and held other offices numerous times.

David's son, Donn, told the foundation, "Dad would be happy with our making an \$11,000 donation and it becoming \$33,000 to benefit the church that he loved so

much." The 2:1 match program offered in November by the Foundation made this possible.

David was a Harrison County councilman and Indiana Fair Board director. He was also a founding member of the Heritage Weekend Festival Committee in Lanesville, a 4-H leader, and an officer and chairman of the Association of Indiana County Councils.

Blank served 22 years on the council, and though many of today's county employees may not have known him, they will see the results of a major accomplishment when they retire. Blank helped establish PERF (Public **Employee Retirement** Fund) as a benefit for employees

"I'm hopeful more families will consider such an endowment to benefit their church or charity. It's a great way to ensure the principal remains intact and earnings are available for years to come", adds

The National FFA Organization (formerly **Future Farmers of** America) envisions a future in which all agricultural education students will discover their passion in life and build on that insight to chart the course for their educations, career and personal future. The FFA motto gives members twelve short words to live by as they experience the opportunities in the organization: Learning to Do, Doing to Learn, Earning to Live, Living to Serve.

Gary has been involved in Agriculture Education and the FFA since 1960 as a student, teacher, and coordinator on many levels of

his career. Jean was an elementary teacher at North Harrison

Elementary since 1984. "Agriculture Education to students and to the public is a vital part of the United States economic, social, and service structure. FFA activities allow students to experience and develop themselves, and to be able to enjoy real world skills that will improve agriculture," said Gary. "It could potentially develop into a career for them. Our two children's careers benefited greatly from their involvement in Agriculture Education and FFA. Jean and I hope this will be used throughout the county in all four agriculture programs to accomplish these goals," adds Geswein.

Additional Funds created in 2010

Town of Corydon Cedar Hill Cemetery Fund: The first burials at Cedar Hill Cemetery date back to the founding of Corydon in 1808. Col. Thomas L. Posey, a public minded citizen, donated the original ground to the Town of Corydon for burial purposes. The Farquar family added a small addition and the remainder of the cemetery was part of the Kintner-McGrain farm of Cedar Glade. This cemetery contains graves of veterans of all wars starting with the American Revolution and graves of Confederate soldiers killed or died following the Battle of Corydon, July 9, 1863. The Town of Corydon maintains the property. The Fund was established in October of 2010 to help the Town maintain common areas of historic Cedar Hill Cemetery.

Lanesville Heritage Weekend Fund: Lanesville Heritage Weekend provides a three day festival celebrating the history and heritage of Lanesville, IN. The first festival was held in 1976 and has given farmers and our community, a place to gather in order to share their memories and heritage. Lanesville has become famous for this event held annually in September and typically draws a crowd of over 80,000. The Lanesville Heritage Weekend Fund was created in December of 2010 to provide support to the festival and the many other community projects of Lanesville Heritage Weekend, Inc.



Harrison County Farm Bureau, Inc. Senior High School **Scholarship Fund**

Harrison County Farm Bureau, Inc. Agricultural Career Scholarship Fund

The Harrison County Farm Bureau, Inc. and its over 1,600 voting members' mission is to be dedicated to promoting agriculture and improving the quality of life of members. With this in mind, two new Scholarship funds were established.

The Senior High School Scholarship will provide scholarships to graduating high school seniors, who reside in Harrison County and are pursuing training or a degree program in the agricultural field. The award for this scholarship is a minimum of \$1,000.

The purpose of the Agricultural Career Scholarship is to provide scholarships to Harrison County students in the agricultural sciences who have successfully completed at least twenty-four (24) hours of college credit with an accumulated GPA of at least 2.8. The award for this scholarship is a minimum of \$1,500.

Marilyn M. Rhodes **Memorial Fund**



Established as a memorial to her sister, Phyllis Rhodes created this fund to provide support to the Harrison County Public Library to purchase materials, equipment, audio-visual media or furnishings.

Marilyn lived in Corydon all her life. During her senior year of high school, she worked half-days at the Old Capital Bank and Trust in Corydon. She retired in 1996 as a branch manager of the Spring Hill Branch, then

called NBD, in Jeffersonville, Indiana.

Marilyn was a lifetime member of Heidelberg United Methodist Church near Corydon. She taught Sunday school class, coordinated and assisted with vacation bible schools, held various offices in the women's group, and played the piano and organ. Marilyn never married and enjoyed traveling with her sister, Phyllis. They were blessed to have visited approximately forty-four

"I believe Marilyn enjoyed reading the most." Phyllis recalls, "As a child, Marilyn, a friend, and I would walk to the Corydon Library. She would check out as many books as the librarian would allow her, which was never enough to please Marilyn."

Marilyn died in September 2009 at age 70 of muscular dystrophy. Through this fund, others will have the opportunity to discover the joy of reading.

"Youth as Philanthropists" **Program Begins**

HCCF began a Youth as Philanthropists program for the 2010-2011 school year. All Harrison County residents entering the eighth through the twelfth grades were eligible.

The Harrison County Youth as Philanthropists (YAP) is designed to teach skills, to encourage youth to give and serve in their communities and to make philanthropy a "habit of the heart".

The seventeen members held their first meeting in September. Members are from Corydon Central High School, Lanesville Jr.-Sr. High School and North Harrison Middle and High Schools. They meet monthly throughout the school year and become more familiar with the Foundation and other charitable organizations in the community. They have made new friends, met community leaders, learned how to fundraise and will soon make their

first grants and conduct a service project. Grantmaking from the

Youth as Philanthropist program is geared toward 'youth driven" service

projects in the community. Youth Philanthropist member Jared Eichmiller from Corydon Central High School said "The people of this community were instrumental in helping my family through a difficult time two years ago when my father had cancer. I now treasure this community. Being a member of this group will allow me to help with the needs of this community as well as give back in ways I could not otherwise do so."

Member Amelia Robertson from North Harrison High School said, "Last year, my friend's sister came back from her stint with the Peace Corps. Since then, my eyes have been opened not only to the need that exists around the world, but also the need that exists in our community. I may not be ready to tackle world hunger, but I can help locally."


